Subject: Change of nomenclature in Functional Head Master- reg

During the scrutiny of Detailed Demand for Grants for the F.Y. 2024-2025, it is observed that under many DDGs, nomenclatures for account heads are depicted in capital letters. As per Para 15.1 of Budget Circular 2024-2025 of Department of Economic Affairs, 'while preparing the DDG it is important to ensure that the classification, namely Major Head, Minor Head etc. is as per the heads of account prescribed in the heads of account prescribed in the List of Major and Minor Head of Accounts'.

The issue is faced particularly in grants where the DDGs have been printed through UBIS data. The matter has been taken up with GIFMIS(o/o CGA) and it has been informed that descriptions under Function Head Master has been updated from capital to proper case and now PrAO users have to perform following tasks:-

- (i) Check the description with the List of Major and Minor Head (LMMH) and initiate necessary changes from the Account Code Editing Functionality available at AAO user of PrAO.
- (ii) PrAOs needs to contact DAMA Section, O/o CGA for initiating changes related to Major Head, sub-Major Head and Minor Head.
- (iii) Changes related to sub Head and Detailed Head, AAO user of PrAO initiate the changes and forward it to PrAO for onward transmission to DAMA Section, O/o CGA.
- (iv) Changes will be updated in the Function Head Master once it will be approved by DAMA Section, O/o CGA.

It is requested that necessary corrigendum to DDG in respect of your grants may be issued after performing the above mentioned tasks. A comprehensive user guide is available on the CGA website www.cga.nic.in and a copy of the same is attached herewith for ready reference.

Subject:- User guide for the users in the Principal Accounts Office to change the nomenclature of Accounting Heads -reg

Reference is invited to changes required in accounting head nomenclature. Presently, no such facility was not available with Principal Accounts office of Ministries/Departments. Now, editing functionality for the change in nomenclature of Accounting Heads as per the Detailed Demand for Grants is developed and placed on the live server of PFMS under the Account Code Editing Module. The functionality works for O/o CGA as well as the Principal Accounts Office.

- 2. DAMA Section, O/o CGA can initiate changes upto Minor Head Level and for heads below minor heads of the accounting heads Principal Accounts Office needs to initiate the changes which will be approved by the DAMA Section after due verification.
- 3. A user guide for Principal Accounts Offices to change the nomenclature/description of Accounting Heads is enclosed.
- 4. All Ministries/Departments/Non Civil Ministries/UTs(without legislature) are requested to use this new editing functionality for change of nomenclature/description of Accounting Heads. For query and discrepancy, if observed, the GIFMIS Section may be contacted under intimation to DAMA section ,so that corrective measures can be taken expeditiously. GIFMIS Section may be contacted for any training on this module, if required.
- 5. This issues with the approval of Addl. CGA (A&FR).

A new interface has been developed on PFMS for initiating changes in function head description if there is any difference in the description/ nomenclature available in PFMS vis-à-vis Detailed Demands for Grant or corrigendum approved by the competent authority. This works at two levels;

 at DAMA Level (from Major Head to Minor Head level) – the request for change will be initiated and approved by DAMA Section users, and (from Sub-Head and Detailed Head), the request for change will be initiated from AAO level of Principal Accounts Office and approved by the Pr. Accounts Officer level. After approval from Principal Accounts Officer level, the request will be then available at DAMA Section, O/o CGA for final approval in consultation with Appropriation Accounts Section, O/o CGA.

remarks / submit the same to DAMA2 user (with remarks) for approval. DAMA 2 user may also redirect the request to Pr. AO user. Option for redirection will be available to both DAMA users.

- (vi) Pr. AO user will redirect the request (redirected by DAMA user) to AAO user for further correction. AAO user have to correct the details and resubmit the same to the Pr.AO user.
- (vii) AAO user may also Delete/Cancel the request.
- (viii) So far as uploading of document is concerned, document uploaded in the first instance will becomes the part of Function Head Master and in case of redirection, if the redirection was caused due to wrong data entry, then the uploaded document(s) will be treated as final


- document and there is no need to re-submit the same after rectification.
- (ix) When the DAMA2 user approves the request, "Proposed Description" would become the part of the Master.
