Subject: Promotion of Lower Division Clerk to the post of Accountant on seniority-cum fitness basis (25% quota) for the vacancy year 2026 – regarding.

* Congratulations to all officials approved for promotion as Accountant. *

The undersigned is directed to refer to this office's O.M. No. NGE:-11004/1/2025-NGE-CGA/564 dated 09.12.2025 on the subject cited above wherein the Departmentalized Accounts Organizations (DAOs) in Ministries/Departments (Civil) were requested to prepare a select list of LDCs in respect of the concerned officials as circulated vide aforesaid O.M. dated 09.12.2025 along with their seniors in case name is not included in the aforesaid list, if any, for consideration of their promotion as Accountant under 25% seniority quota for the vacancy year 2026 and subject to fulfilment of the eligibility conditions mentioned in Rule 5(2) of relevant Central Civil Accounts Service (Accountant Group 'C' posts) Recruitment Rules, 2021 and availability of vacancies under 25% seniority quota for the vacancy year 2026.

- 2. On the basis of select list received from Ministries/Departments, a combined select list was prepared in respect of LDCs who have been found 'FIT' and recommended by DPC (Gr.'C') held in their respective Ministries/Departments for promotion to the post of Accountant and fulfilled all essential eligibility conditions as on 1st January of the vacancy year 2026 prescribed in Central Civil Accounts Service relevant recruitment rules of the post of Accountant, the approval of the Competent Authority is hereby conveyed for promotion of total Forty Four (44) LDCs as Accountant on seniority-cum-fitness basis (25% quota) and allocation of Ministries/Departments and stations on their promotion as Accountant against the available vacancies for the vacancy year 2026. The List of Forty-Four (44) LDCs approved for promotion as Accountant, is enclosed as per ANNEXURE-I to this O.M.
- 3. The Appointing Authorities of the Ministries/Departments are therefore, requested to issue promotion order in respect of LDCs approved for promotion as Accountant and allocated to Ministry/Department as per list annexed at Annexure-I. However, before issue of promotion order, the following may be ensured: -

- 3.1 the official fulfills all eligibility conditions as mentioned in Recruitment Rules of the post of Accountant including clearance of the probation period and correctness of service particulars of the official, etc.;
- that none of the circumstances exist for adoption of sealed cover procedure in the concerned case, as per instructions issued by DOP&T vide OM dated 14.09.1992 and as amended from time to time;
- 3.3 that official is not undergoing any penalty under CCS(CCA) Rule, 1965; and
- 3.4 that disciplinary proceedings are either not pending or being contemplated against the official.
- 4. The promotion of LDCs whose names approved as per list at Annexure-I, to the post of Accountant on seniority-cum-fitness basis (25% quota) shall be effective from date of assumption of charge to the post of Accountant on promotion, on or after 01st January 2026, as the case may be.
 - 4.1 The officials approved/promoted to post of Accountant shall require to pass the Departmental Confirmatory Examination for Accountants conducted by Controller General of Accounts in terms of the Central Civil Accounts Service (Accountant, Group-C post) Recruitment Rules, 2021 and the regulations of said examination.
- 5. For timely promotion of LDC approved for promotion as Accountant, the following course of action may be ensured on immediate basis: -
 - 5.1 The Ministry/Department where the concerned official is currently posted may send vigilance clearance report (in prescribed proforma enclosed herewith) immediately to Ministry/Department where the allocation has been made.
 - 5.2 Appointment order is to be issued by the Ministry/Department allocated on promotion after receipt of vigilance clearance from the parent Ministries/Departments.
 - 5.3 The Ministry/Department where the concerned official is currently posted, shall serve the promotion order and relieving order simultaneously to the official concerned so as to enable the official to assume charge of the promoted post of Accountant on or after 1st January 2026, as the case may be.
 - 5.4 In case of allocation on promotion as Accountant in same Ministry/Department, the process as mentioned at Para 3.1, 3.2 & 3.3 for promotion of the official shall be completed well within due course of time.
 - 5.5 A copy of relieving and joining order shall be forwarded to this office invariably.
- 6. Also, a report in the following format as on 01st January 2026 and 16th January 2026, shall be furnished to O/o the CGA immediately after due dates: -

- 9. The representations for change of allocation or the forego requests, received in this office (i) without following the procedure prescribed in this office's ibid O.M. dated 26.10.2021 and (ii) after due dates mentioned in Para 7 & 8 above, shall not be entertained in any case.
