- 2. CCAs/ CCAs/ CAs are, therefore, requested to relieve all the concerned AAOs / Sr. AOs under their administrative control latest by **January 15th**, **2025** failing which AAOs/ Sr.AOs mentioned in the lists enclosed will **'Stand Relieved'** from the rolls of the Ministry/Deptt. to join their duties in the allocated Mins/Deptt as per the relevant orders w.e.f. **16th January**, **2025**, if not already relieved. No formal relieving orders from their present Ministry/Department will be required thereafter.
- 3. All concerned AAOs/Sr. AOs as per the lists will ensure that a copy of the joining order is simultaneously endorsed to the undersigned also.
