Sub:- Reducing the limit of Inter Accountal Adjustment Advice (IAAA) from exceeding Rs. 100 crore to exceeding Rs. 75 crore

Please refer Office to Memorandum No. S-11012/1(12) HLM/2012/RBD/1281-1337 9th dated August 2016, No. 10012/1(12)/HLM/2012/RBD/1358-1410 dated 17th August 2016 and No. S-11012/1(12)/HLM/2012/RBD/1414-1460 dated 22nd August 2016 (copies enclosed) on the subject cited above.

- 2. It has been decided in consultation with Reserve Bank of India to reduce the limit of Inter Accountal Adjustment Advice (IAAA) transactions from existing exceeding Rs. 100 crore to exceeding Rs. 75 crore with effect from 16th July 2025. The account with accredited bank would not deal with such transactions and payment of the transactions exceeding Rs. 75 crore would be released through the e-kuber system of the Reserve Bank of India as in the case of existing limit of exceeding Rs. 100 crore.
- 3. RBI would provide the e-scrolls/debit notifications, account statement and account wise DMS to the concerned PAOs as hitherto for accounting and reconciliation purposes.
- 4. Pr. CCAs/CCAs/CAs (independent charge) of all the Ministries/Departments are, therefore, requested to bring this to the notice of all the PAOs under their control and in case any new IAAA account needs to be opened by any PAO on account of reduction of threshold limit, concerned PAO may please be advised to approach Government Banking Division, Mumbai Regional Office, RBI, Mumbai at padmumbai@rbi.org.in (Phone No. 022-22603405/22603424).

Opening of Bank Accounts by Pay and Accounts Offices in Reserve Bank of India for collection of revenue under Non Tax Revenue Portat (NTRP) and for arranging e-payments for Rs.100 crore and more under Inter Accountal Adjustment Advice (IAAA).

The Non Tax Revenue Portal (NTRP) has been made operational by PFMS for collection of Non Tax Revenue of Government of India and all the Pay and Accounts Offices are expected to be integrated with the NTRP shortly for collection and accounting of non tax revenue.

The inter Accountal Adjustment Advice (IAAA) would be made operational shortly by PFMS for payments exceeding Rs.100 crore to PSU's and Other Parties including Private parties.

The Reserve Bank of India would be collecting non-tax revenue through NEFT/RTGS, modality and reporting the collection via e-scrolls to the PAOs. The same would be the case in operation of IAAA where RBI would make e-payments for amounts exceeding Rs.100 crore, directly to PSU's/Other Parties etc. and it would send e-scrolls for such payments to PAOs as well.

In this scenario it is essential for all the Pay and Accounts Offices of Civil Ministries to have E-FPB account in Reserve Bank of India for payments and receipts. The account with the accredited bank would not deal with such transactions once these e-FPB accounts with RBI becomes operational and PAOs have integrated with NTRP.

Pr.CCAs/CCAs/Dy.CAs of all the Ministries/Departments are therefore requested to direct PAO's under their control to open an e-FPB account with RBI for such payments and receipts immediately. The information may be sent to the RBI by the PAO in the prescribed format (enclosed).
