OFFICE MEMORANDUM

The PDs are requested to present the details of the current CNA(s) and the Sub Agencies and the proposed hierarchy of Funding Agency/Recipient Agency. The representatives of the Bank(s) in which the Bank Accounts of Current CNA(s) were opened may also be requested to attend the Open House for discussion on the bank account related issues.

3. The purpose of the open house is to firm up the structure of Funding/Recipient agencies, the hierarchy of RBI/bank accounts and aid in other operational and technical matters. Accordingly, this may be widely circulated to all PDs and agencies to ensure wide participation by all concerned.
