4. The Departmentalized Accounts Office issuing promotion order may also inform the above official that he can be debarred of promotion as per DoP&T orders if declines to accept promotion and thereby loose inter-se-seniority.
5. Refusal by individual to accept promotion will be subject to acceptance by this office.
