
3. The honorarium payable to the Inquiry Officers will be regulated in terms of DoPT O.M. No. DOPT-1668597747466 dated 16.11.2022.

No. 11021/36/2023-PP.A-III dated 11.10.2023, the Officers designated as Inquiry Officers are requested to ensure to complete the prescribed course relating to procedural steps for holding Disciplinary Proceedings/Departmental Inquiries on the iGOT Karmayogi Platform, including the course "Conduct of Enquiry in Disciplinary Matters", so as to avoid procedural lapses in conduct of department Inquiries. Further, it is also requested that the empanelled Inquiry Officers adhere to the instructions/guidelines issued by DoPT from time to time relating to conduct of departmental inquiries and disciplinary proceedings.
