OFFICE MEMORANDUM

SUB: Encadrement of the posts of Sr. Accounts Officers/ Accounts Officers and Asstt. Accounts Officer.

The Competent Authority is pleased to approve the encadrement of the 10(ten) posts of Senior Accounts Officers and 10 (ten) posts of the Asstt. Accounts Officers created for UIDAI in the M/o Planning in Civil Accounts Organisation under the Controller General of Accounts on the following terms and conditions.

1. The posts of Senior Accounts Officers will be classified as "General Central Service Group 'B' Gazetted-Ministerial in the pay band-PB-3 of Rs. 15600-39100 with Grade Pay of Rs. 5400.
2. The posts of Assistant Accounts Officers will be classified as "General Central Service Group 'B' Gazetted-Ministerial in the pay band-PB-2 of Rs. 9300-34800 with Grade Pay of Rs. 4800.
3. The Controller General of Accounts will be the Cadre Controlling Authority for the above posts.
4. The services of Sr. Accounts Officers (SAOs) will be governed by the Central Civil Accounts Service (Pay & Accounts Officer and Senior Accounts Officer) Recruitment Rules, 2000 and other administrative instructions/ policies issued by the office of the CGA from time to time.
5. The services of Assistant Accounts Officers (AAOs) will be governed by the Central Civil Accounts Service (Asstt. Accounts Officer/ Junior Accounts Officer) Recruitment Rules, 2000 and other administrative instructions/ policies issued by the office of the CGA from time to time.

6. The allocation of Sr.A.Os and A.A.Os. will be made by the Controller General of Accounts against the said posts. The Post of Sr. Accounts Officer will, however, be interchangeable among Sr.A.Os and A.Os.
7. Two posts of Sr.A.Os will be at UIDAI (Hqrs. at Delhi) and eight posts will be at UIDAI Regional Offices located at Bangalore, Chandigarh, Guwahati, Hyderabad, Lucknow, Mumbai, Delhi and Ranchi. Similiarly, two posts of A.A.Os will be at UIDAI (Hqrs.) and eight posts will be at UIDAI Regional Offices. Four posts of Accountants will be at UIDAI (Hqrs.) and eight at Regional Offices of UIDAI.
