OFFICE MEMORANDUM

Subject: Combined seniority list of Sr. Accountant for promotion as Assistant Accounts Officer under 10% quota.

Reference is invited to this office OM No. A-35018/1/2012/MFCGA/AAO/CSL 10%/161 dt.14.05.13 and No. A-32016/5/2012/MFCGA/AAO 10%/355 dt.10th July'13 uploaded on the website on the subject cited above.

The Departmental Promotion Committee met on 13.08.13 and found 22 cases FIT for promotion (Annex-I), deferred 13 cases for wanting of ACRs etc (Annex-II) and found 1 case Unfit (Annex-III) while considering for promotion of Sr. Acctt. as Assistant Accounts Officer under 10% quota. The individual promotion approval will be issued separately in order of seniority and subject to availability of vacancies under 10 % quota for Vacancy year 2012-13.

In this regard, it is pertinent to mention that inspite of repeated reminders ACRs were not received in r/o officials mentioned in Annex-II and non-submission of ACRs clearly indicates that time schedule for submission of ACRs laid down in OM No.35014/4/83-Estt.(A) dt.23.09.85 has not been adhered to. As per provision, if self-appraisal of the officer to be reported upon is not received in time, the reporting officer should take it upon himself to remind the officer in writing failing which report should be initiated without self-appraisal.

It is therefore, again, reiterated that ACR of all the Sr. Acctts. listed in Annex-'II' should be completed in view of laid down provision. In case of failure, the responsibility of consequences in respect of left-out eligible candidates will lie on the office concerned.

This issues with the approval of Jt.CGA.
