

3. **Important instructions:**

- Coordination Section will be responsible for forwarding the RTI cases to the concerned CPIO/ Appellate Authority. Any other issue relating to interpretation of the provisions RTI Act or any policy decision relating to RTI shall be handled in CDN Section through its own channel of submission.
- The CPIOs are under statutory obligation to provide information sought by the citizen and it does not require any formal approval. They may informally consult their reporting officer in cases of doubt. In no case RTI application seeking information may be put up on file for approval.
- CDN section shall mark the RTI applications to the CPIO who appears to be the most closely connected with the subject matter of the application. Thereafter, the CPIO shall dispose off the application as per the provision of the RTI Act, 2005. Under no circumstances, the CPIO shall return the application to CDN section merely on the ground that the information sought is not available with the CPIO.


