OFFICE ORDER



2. The appointment on promotion will be subject to the following terms and conditions:

- i) It will be in an officiating capacity.
- ii) The appointment will be without prejudice to the claim of their seniors entitled to receive prior appointment.
- iii) The placement of the official for appointment in the above Ministry/ Department is provisional and may be changed, if necessary.

3. The O/o Pr. CCA, CBDT and O/o CCA, Commerce may issue orders for promotion of the above officials as Private Secretary after satisfying that none of the circumstances for adoption of sealed cover procedure as laid down in the DoP&T OM No. 22011/4/91/Estt.(A) dated 14.09.1992 or in any subsequent instructions of the Government of India exist and ensuring that the officials are not undergoing any penalty under CCS (CCA) Rules, 1965 incorporating the terms and conditions in Para 2 above with a copy to this office.

4. The Departmentalized Accounts Office issuing promotion orders may also advise the above officials that they can be debarred of promotion as per DoPT orders if decline to accept promotion and thereby loose inter-se-seniority.
5. Refusal by individual to accept promotion will be subject to acceptance by this office.
6. The date of taking over as Private Secretary by the officials may be intimated to this office.
