Office of the Director of Canteens frames Model Recruitment Rules in respect of various Group 'B' and 'C' posts in Non-statutory departmental canteens functioning from Central Government Offices all over India from time to time. Based on these Model Recruitment Rules, all the Ministries/Departments are requested to adopt and notify the RRs. The Model Recruitment Rules were circulated wide this Department's O.M. No.-3/2/2009-Dir.(C) dated 22.05.2013 and 04.06.2014. However, it has come to notice that a large number of Ministries/ Departments have not yet adopted and notified the RRs for the posts in Non-Statutory Departmental Canteens. In the absence of notified RRs, not only are the posts lying vacant at all levels but also the existing canteen employees are not getting timely promotions in the Departmental Canteens. Besides, harming the careers of the canteen employees, this situation also adversely impacts the services of the canteens.

2. We would like to know the current position regarding adoption/ notification of RRs for canteen posts in Non- Statutory Department canteens functioning under your Ministry/ Department. In case, Recruitment Rules have not been notified, I request you to adopt and notify RRs on the basis of the aforesaid Model Recruitment Rules for Group 'B' and 'C' posts in the Departmental Canteens functioning under administrative control of your Ministry/ Department and to kindly inform us about the action taken in this regard within a month.
