

In pursuance to the order of DOP&T OM No. AB 14017/64/2008-Estt.(RR) dated 24<sup>th</sup> April, 2009, OM No. AB 14017/64/2008-Estt.(RR) dated 1<sup>st</sup> July, 2010 and OM No. AB. 14017/30/2011-Estt.(RR) dated 2<sup>nd</sup> September, 2015, approval of the competent authority has been accorded for grant of Non-Functional up-gradation to the following ICAS officer of 1983 batch to Higher Administrative Grade(HAG) pay scale of Rs. 67000-79000/- with effect from 29<sup>th</sup> July, 2015:-

2. Smt. Sujata Prasad, ICAS(1983), who is posted under the Central Staffing Scheme, will be granted one increment on account of the non-functional upgradation, but her grade pay will remain same on the ground that she is holding a particular post with a specific grade pay under the Central Staffing Scheme. In such case the officer granted non-functional upgradation may continue to draw CDTA, if admissible.

3. The up-gradation granted under these orders are purely Non-Functional up-gradation personal to the officer and it does not bestow any right to the officer to claim promotion or deputation benefits based on Non-functional up-gradation in such a manner.
